NAPEO took members to the Department of Labor, where U.S. Secretary of Labor Alex Acosta—a member of the president's cabinet—spoke directly to the group (the first time a Secretary of Labor has addressed NAPEO!). He emphasized the DOL's and PEOs' common purpose: to empower the American workforce. Attendees then walked to Capitol Hill for lunch in the Rayburn House Office Building, where they heard from several congressional speakers. Tuesday capped off with the Stars & Stripes Gala. The educational portion of the conference began Wednesday, highlighted

NAPEO's Board of Directors attended to the business of the association on Monday, before the PEO Capitol Summit officially kicked off. As always, the board began by reviewing the health of the association, which is robust, with the Treasurer's report. President and CEO Pat Cleary reported on the strategic plan, which is nearing the end of its term and in its final phase of reaching its goals for NAPEO. There was lively discussion about Chair Norman Paul's initiatives: the bylaws update

Chairs of the various committees—Federal Government Affairs, State Government Affairs, Healthcare, Leadership Councils, and Membership Services—reported their progress to the board. Of particular interest was the report by the Marketing & Communications Committee about the proposed industry marketing plan using the findings of NAPEO's market research project.

Government Affairs Committee Meetings

NAPEO's Federal Government Affairs Committee, led by Chair Dawn Davidson Drantch and NAPEO VP of Federal Government Affairs Thom Stohler, had a full agenda. Updates were provided on joint employment, immigration, the Occupational Safety and Health Administration enforcement manual, Form 5500, association health plans, the proposed expansion of short-term limited-duration insurance, and the use of health reimbursement accounts. The committee approved presenting the FGAC operational guidelines to the board for approval.

State Government Affairs Committee Chair Kerim Fidel was joined by NAPEO Senior Director of State Government Affairs Daniel Harris and SGA Directors Melissa Kelly and Michael Kreiter. Priority state updates included Georgia, Kansas, Massachusetts, Missouri (where the NAPEO bill was recently signed by the governor), Ohio, and Texas. The committee also discussed state retirement plans, an exclusive remedy win in Montana, pay equity, employee classification, and the upcoming 2018 state elections.



NAPEO's first stop on Capitol Hill was the Department of Labor, where U.S. Secretary of Labor Alex Acosta spoke of the DOL's goals of growing the American workforce, restoring common sense to regulations, providing greater clarity for compliance, and leveling the playing field for small businesses. He said that PEOs have the unique ability to aggregate issues for their clients and bring them to the DOL. Solicitor Kate O'Scannlain and Acting Assistant Secretary of the Occupational Safety and Health Administration (OSHA) Loren Sweatt also spoke, reiterating the DOL's desire to assist in compliance, prevent violations, and provide guidance.


Speakers and Lunch on Capitol Hill

The focus on PEOs and their positive impact on small business continued on Capitol Hill as NAPEO attendees enjoyed lunch in the Rayburn House Office Building and heard from Members of Congress and committee counsel. Rep. Joe Wilson (R-SC) thanked PEOs for what they do for small business, particularly helping them stay in business, grow, and thrive. He said Members of Congress have open doors and are happy to help with small business issues. These sentiments were echoed by Rep. Mike Coffman (R-CO) and Rep. Trey Hollingsworth (R-IN), who has a background in small business and said he sees the value PEOs bring to companies in his district. Rob Green, labor policy counsel for the Education and Workforce Committee, described the committee's involvement in oversight of labor management issues, pension reform, retirement security, benefits and healthcare, and federal contractors.



While on Capitol Hill, NAPEO members split off to visit their Members of Congress. Sixty members had a total of 194 individual appointments. PEO members explained the PEO industry, talked about their presence in their respective Member of Congress' districts, promoted PEOs as experts in compliance and employment law, and offered to be conduits to small businesses in their congressional districts. The key issue members discussed with Members of Congress was eligibility of PEO clients for the pass-through entity tax deduction.


